**Call for applications for mobility grants for participation in the
Shaping a World Class University**

**Summer School in “Photosensitive drugs: from therapies to instability, loss of activity
and toxicity”**

Granada (ES), 17-21 luglio 2023.

With this call for applications, the University of Padua - Department of Pharmaceutical and Pharmacological sciences offers 10 mobility grants for participation in the Shaping a World Class University - Summer School in “Photosensitive drugs: from therapies to instability, loss of activity and toxicity”. Blended Intensive Programme in which the University of Padua is a partner. The mobility programmes will take place at Facultad de Farmacia, Universidad de Granada.

Art. 1 General Information

The lessons (25 total hours) will be held by Italian and foreign teachers from Monday 17 July 2023 to Thursday 20 July 2023.

At the end of the lessons, on Friday morning 21 July 2023, students will have to pass a final exam (multichoice questions) obtaining a certificate of participation.

For students enrolled in Pharmacy and Pharmaceutical Biotechnologies degree courses, 2 credits will also be credited for the School:

These credits will be registered for Pharmacy and Pharmaceutical biotechnologies students as "Other activities" such as "In-depth study of particular aspects of the pharmacist profession".

The Summer School will provide the basic principles of photobiology and photochemistry of photosensitizing biomolecules as well as their applications in pharmacological phototherapy and photodiagnosis. In particular, the lessons will focus on UV light (from cells to skin tissue, DNA damage, effects of Vit. D); Photomedicine; Photodynamic therapy and fluorescence diagnosis; Photopharmacology; Photodermatology; Photoprotection; Biochemistry on light; Photostability of drugs.

Art. 1.1 Who can benefit

This Call for Applications is addressed to:

- ✓ students regularly enrolled at the University of Padua for the Pharmacy, Chemistry and pharmaceutical techniques, Pharmaceutical Biotechnologies degree courses
- ✓ PhD students interested in pharmaceutical, pharmacological, medicinal chemistry, therapies and diagnosis

Art. 1.2 Host Organisation

The organisation where the students' activities will take place is at **Facultad de Farmacia, Universidad de Granada**.

Art. 1.3 Duration and period of stay abroad

The programme provides for a mobility of 6 days to be carried out in the period **16-21 July 2023**.

In the event that, for health emergency reasons, the course cannot be attended at Facultad de Farmacia, Universidad de Granada all activities will be carried out exclusively online and grantees will not benefit from the relevant mobility grant.

Art. 1.4 Contributions and Economic Benefits

In-person mobility alone will be financed through the Shaping a World Class University programme for the days actually spent abroad up to a maximum of **500,00 Euro**. Funding will be disbursed upon completion of the mobility period on the basis of the documentation provided by the host university confirming participation. Only participants who have fulfilled all their obligations under the programme will be entitled to receive the contribution.

In the event that additional mobility grants can be funded, they will be offered to those further down the ranking list.

Art. 2 Admission requirements and submission of applications

Art. 2.1 Admission requirements for the Call for Applications

In order to participate in the selection, the candidate must meet the following requirements when submitting the application:

- a) must be regularly enrolled at the University of Padua in one of the following course units: Pharmacy (4° and 5° year), Chemistry and pharmaceutical techniques (4° and 5° year), Pharmaceutical Biotechnologies (1st and 2nd year)
- b) must have made all required payments for tuition fees;
- c) Students enrolled in individual Study Courses ARE NOT ELIGIBLE;
- d) must have good knowledge (min. level B2) of English;

Art. 2.2 Submission of the application

To apply for the programme, students must submit the following documents:

- Duly signed Application form for the call for applications (attached to this notice and also available at the link: <https://www.dsfarm.unipd.it/news/termine/90>)
- Curriculum Vitae in European Format (in English)
- Copy of a valid identity document
- Any language certificates, certificates of international experiences carried out and the Europass declaration of knowledge of foreign languages (in English)
- Motivational letter (in English)

The documentation must be submitted

- Delivered by hand directly to the Department of Pharmaceutical Sciences Settore Didattica e Post Lauream - Via F. Marzolo, 9 1 - 35131 Padova, from Monday to Friday (9 am – 1 pm);
- sent by registered mail with return receipt (the candidate must make sure that the application is received by the time and date indicated above);
- sent via PEC.

In the case of submitting the application by PEC, the application must be sent to the address:

- by certified e-mail (PEC), accompanied by a digital signature affixed to the same and to all documents in which the affixing of the handwritten signature in a traditional environment is envisaged;
- by certified e-mail (PEC) by sending a copy of the signed application, together with a copy of the subscriber's identity document; all documents in which the affixing of the handwritten signature in a traditional environment is required must be similarly transmitted in a signed copy. Copies of these documents must be scanned;
- via PEC - personal ID of the candidate (in compliance with the regulations indicated by the DCPM of 27 September 2012) together with the relative documentation.

For the electronic submission of documentation, static and non-directly modifiable formats must be used, free of macro-instructions and executable codes, preferably PDF. The documents must not exceed 1MB in size.

All applications must be submitted by **17 April 2023 – 12 am**

Applications cannot be received by any other means, and incomplete applications will be automatically excluded.

Art. 2.3 Selection Criteria

Applications will be selected by a special Department Committee.

Selection will be based on the following criteria:

- 1) evaluation of the curriculum vitae et studiorum:
- 2) evaluation of language knowledge, based on the qualifications submitted and the Europass declaration; language skills: evaluation of the language certificates submitted; evaluation of the

language exams passed. In the event of a tie, the candidate with the highest level of language knowledge will be selected.

- 3) assessment of motivation: evaluation of the candidate's interests and aptitudes as outlined in the motivational letter; consistency with the student's profile and suitability of the activities for obtaining ECTS credits.

Art. 2.4 - Ranking list

The ranking list and the instructions for accepting the mobility grant will be published on the webpage:

Winners must confirm their acceptance of the assigned mobility grant, following the instructions that will be provided in the ranking list. In the event of non-acceptance, the student will be deemed to have withdrawn.

Art. 3 Grant disbursement modalities

The personal, tax and bank details used for payment will be those entered by the students in their personal area on Uniweb. Students are required to verify that they have properly entered and updated this data.

The method of payment for mobility to the student is exclusively by bank transfer to the account in the name (or joint name) of the beneficiary.

Article 4 - Insurance

For health insurance coverage during a stay abroad in countries of the European Union, Iceland, Liechtenstein and Norway, it is generally sufficient to carry the European Health Insurance Card (EHIC) issued by the Ministry of Health. Attention: non-EU students registered with the Italian national health service may not use their EHIC card, since this is not provided for by current EU legislation (Regulation EC 859/2003). They are therefore invited to contact their local health authority for information.

The tuition fees paid by students also include accident and civil liability insurance, which is also valid for those travelling abroad. The aforementioned insurance only covers accidents occurring during learning and/or internship activities.
